 - a. MyPharmacyOnline.ca is providing an online model that does away without the overhead for individual pharmacies there is a storage facility in Saanich therefore they can pass on the savings to the consumers and provide an income stream to our school potentially. They provide same day or next day delivery for residents in the Greater Victoria area. Canada post for all other areas. This company provides a one \$5 gift card per medicine prescribed per prescription. They also offer reduced drug costs in comparison to other pharmacies. They are also optimizing all the different insurance plans.

V. Director's Report

- 1. Library

- 2. Adult Registrations
 - a. Saturday classes have good numbers for registration. Tuesday class only has had one registration.
- 3. Sprachbeihilfe for 2014/15

- b. The Board may have to consider paying an Admin person more in order to create more stability. The Admin is getting \$12.50 working up to 10 hours per week. The Admin position has a budget of about \$6,090 per year. Based on 420 hours in a school year.

- d. Petra Gerard is a mother and she is willing to attend on Tuesdays and she will be paid \$12.5/ hour
- e. Amartina to provide an e-copy to provide us to the Board for the job duties of the Tuesday evening person.
